Government Aid

Federal Pell Grant

\$740—\$7,395 per year

The Pell Grant is a federal grant program, which is awarded based on financial need as determined by the FAFSA.

Federal Supplemental Educational Opportunity Grant (FSEOG)

Up to \$2,000 for the first year

Up to \$1,000 for subsequent years

The FSEOG is a federal grant designed to help students with the highest need as determined by the FAFSA. Funds are limited.

Cal Grant

\$9,358 per year (for current 1st year recipients)

Cal Grant is funded by the State of California to California residents who meet GPA and financial criteria.

To be considered, students must submit a FAFSA and a GPA Verification Form no later than March 2. Subject to change pending state budget approval.

Federal Direct Student Loan

Freshmen may borrow up to

\$5,500

Sophomores may borrow up to

\$6,500

Juniors and Seniors may borrow up to

\$7,500

Independent students may borrow additional unsubsidized loans. Repayment of the loan begins six months after students leave school or fall below half-time status.

Direct Subsidized Loan

While students are in school, the government pays the interest on the loan. Based on need. Current interest rate of 6.39%.

Direct Unsubsidized Loan

Interest will accrue while students are in school. Not based on need. Current interest rate of 6.39%.

Federal Direct Parent Plus Loan

Federal loans for parents of dependent, undergraduate students. Repayment begins within 60 days after the final disbursement at a minimum of \$50 per month with a fixed interest rate of 8.94%.

Institutional Grants And Scholarships

\$10,000 per year

A minimum of \$10,000 of institutional gift aid is guaranteed for each new student in full time units.

Trustees Scholarship - \$18,000

4.0 GPA and above

Presidents Scholarship - \$17,000

3.9–3.99 GPA

Deans Scholarship - \$16,000

3.3–3.89 GPA

Directors Scholarship - \$14,000

2.95–3.29 GPA

Academic Scholarships are based on a student's cumulative weighted GPA. These scholarships are guaranteed if academic requirements are met. Renewable if a minimum of a 2.0 GPA is maintained.

TRANSFER

Transfer Platinum - \$15,000

3.75 GPA and above

Transfer Gold - \$14,000

3.5–3.74 GPA

Transfer Blue - \$13,000

3.0–3.49 GPA

Transfer Bronze - \$11,000

2.5–2.99 GPA

To be considered a transfer student you must have completed 24 or more units from an accredited college or university. These scholarships are guaranteed if academic requirements are met. Renewable if a minimum of a 2.0 GPA is maintained.

Minister's Kin

\$3,250 per year

The recipient must be the dependent child of a minister engaged in full-time service as a pastor, chaplain or missionary. For further information, contact the Admissions Office.

Multiple Sibling

\$2,000 per year

For students with at least one sibling who is simultaneously attending the traditional, undergraduate program on a full-time basis. For further information, contact the Admissions Office.

Need-Based Grants

CBU Grant

A need-based grant awarded by CBU's Financial Aid office. FAFSA is required to determine eligibility.

CBU Cal B Assistance

\$7,710 for the first year

For students that qualify for Cal Grant B from the State of California.
